Rules and Regulations of Transparency Watch Organization

Eligibility for Membership:

Any person having the following qualification shall be eligible for membership of the organization:-

- i) Who is of or above 18 years age.
- ii) Who has reputable character and sound mind?
- iii) Who agrees to abide by the constitution and bye-laws of the foundation and supports the aims and objects of the organization.
- iv) Who agrees to pay the prescribed fee of the organization.
- v) Who interested in Social Work.

Categories of Membership:

i) Patrons:

Fee for Patrons Membership for Rs. 1500/- or more in lump-sum to the Association.

ii) Life Member:

Life Membership for Rs. 1000/- to the Association shall be Paid by the Provincial Executive Committee to become a Life Member of the Association.

iii) Ordinary Member:

Annual Membership Fee of Rs. 500/-

Conditions:

1. Members can create awareness about the role of Transparency Watch Organization amongst the people in their areas
2. Members should coordinate with other people who are working for the transparency in Pakistan.
3. Members should inform TWO registered office about Corruption cases that are taking place in their areas or in their knowledge.
4. Any person who is doing voluntary work for TWO must inform registered office.
5. Transparency Watch Organization Head Office reserves the right to give memberships to volunteers
6. Volunteers will only use the TWO membership card for TWO's work
7. Volunteers must have a valid National Identification Card issued by NADRA
8. Volunteers will submit a copy of their National Identification Card and two passport size photographs along with Membership application form
9. Volunteers must apply for renewal of their membership One Month prior to the expiry of their membership
10. Membership shall be renewed based on the past performance of members
11. In case a volunteer violates the Transparency Watch Organization Volunteer Membership rules, TWO reserves the right to cancel a volunteer's membership without any notice.

Transparency Watch Organization will not be responsible for any personal action of a volunteer
